VegasT1 shall perform the Services in a good and workmanlike manner and in compliance and in accordance with all applicable federal and Nevada laws and regulations and the terms and conditions contained in the agreement. VegasT1 is not responsible for loss of service in the event of Terrorism, Mother Nature, Customer abuse, and or other ISP or telco provider outages, but will do everything reasonably possible to restore service.

SECTION 3

COMPENSATION/PAYMENT

Customer agrees to accept the Services described in this Agreement and to pay VegasT1 all amounts due hereunder in. . Following the end of each monthly billing period, VegasT1 shall bill the Customer for all amounts due VegasT1 hereunder for such billing period (including, but not limited to, all standard repetitive charges, all charges for additional requested Services, and other charges incurred by Customer whether contemplated by this Agreement or agreed to by independent written contract or verbal contract or otherwise requested). Payments shall be made

by Customer when invoice is rendered. VegasT1 reserves the right to charge and Customer agrees to pay interest at the rate of One and One Half Percent (1.50%) monthly, or Eighteen Percent (18%) annually, on any unpaid obligations which remain unpaid for a period of more than 30 days.
